



OURO PRIVACY RIGHTS REQUEST FORM

The term "Personal Data" means any data we collect (such as name, contact information, social security number, etc.) that can be used to identify an individual or household, either directly or indirectly. We do not sell your Personal Data. We shall endeavor to respond to a verifiable consumer request within forty-five (45) days of its receipt. If we require more time (up to another 45 days), we will inform you of the reason and extension period. We do not charge a fee to process or respond to a verifiable consumer request unless it is excessive, repetitive, or manifestly unfounded. Depending on your state of residency, you may have certain rights respecting your Personal Data. These rights, which may be limited subject to Federal law, typically consist of the following:

Right to Know and Access Your Personal Data

You have the right to request a copy of the Personal Data that we have about you. Please note we may not be able to provide information relating to investigations, claims, litigation, and other matters.

Right to Correct Your Personal Data

You have the right to request correction of the Personal Data we may have recorded about you, considering the nature of the Personal Data and the purposes of the processing of that Personal Data.

Right to Delete Your Personal Data

You may request us to delete Personal Data if no exception exists under applicable regulations. We have a process in place to analyze any exemptions and determine the validity of the request. We can comply with this request by de-identifying the Personal Data, aggregating the consumer information, or by permanently and completely erasing the Personal Data on its existing systems with the exception for archived or back-up systems.

Right to Opt-Out of Sharing & Targeted Marketing

You have the right to request that we stop the sharing of your Personal Data as well as to request to opt-out of targeted advertising.

Rights to Non-Discrimination

You have a right to not be discriminated against because you exercised any of the rights provided under state law by being: denied goods or services; charged different prices or rates for goods or services, including through the use of discounts, benefits, or imposing penalties; provided a different level of quality of goods or services; or offered a different price or rate for the goods or services, or a different level or quality of goods or services.
